## Statement of Faith

### God

There is one God who created all things. In order to save us, He became man. Jesus Christ was God in flesh, Emmanuel -- God with us (Matthew 1:23). Jesus died on the cross as a sacrifice for our sins according to the scriptures. Further, He arose bodily from the dead and ascended into heaven (Romans 3:22-26).

### Jesus Christ

We believe that Jesus Christ is true God and true man, having been conceived of the Holy Spirit and born of the Virgin Mary. He died on the cross as a sacrifice for our sins according to the Scriptures. Further, He arose bodily from the dead and ascended into heaven, where at the right hand of the Majesty on High, He is now our High Priest and Advocate, and in the person of the Holy Spirit, He dwells the believer. (Matthew 1:18-25)

### The Gospel

The gospel of the kingdom is the message that the church of Jesus Christ has been commissioned to teach. The gospel of the kingdom declares that the days of human government are numbered and that God will soon set up a kingdom that shall never pass away. When the kingdom of God is established, Jesus will reign as King of kings and Lord of lords (Daniel 2:44).

### Scripture

The Bible, in its original manuscripts, is the inspired word of God, and it reveals the will of God to the human race. The Holy Scriptures are the final authority in matters of faith and truth (II Timothy 3:16-17).
